

Angola Business visa VCD Short Stay - Cape Town

Requirements

Negative COVID- 19 Coronavirus test is compulsory and must be issued 48 hours before submission of any application, not older.

VCD short-stay visa validity: Travellers have 72 hours to enter Angola and may stay for 10 days after entering the country. An extension may be requested through the Home Office after arrival but is at their discretion.

If SA passport holders are arriving in Angola by VEHICLE, they will get a stamp at the border post of Santa Clara which is between Angola and Namibia. 1. Pax to be in possession of a certified copy of the vehicle documentation at any Police Station within South Africa/. 2. Yellow fever card as well as proof of accommodation in Angola

Applications must be submitted one day prior to actual appointment date and all applicants will be met at the Consulate by a Visas Zone representative.

Valid Passport, at least 12 months validity from date of return (Foreign passport holders require valid residency in South Africa).

Updated letter in Portuguese and addressed to the Cape Town Consulate and include the following:1. Full name and CORRECT PASSPORT NUMBER of applicant 2. Clear Host Company and Angolan authority stamps 3. EMAIL ADDRESS OF INVITING PERSON + copy of Identity document + proof of office address/ postal code 4. Departure date and duration of stay 5. Company bank statements or proof of address 6. Category visa to be issued with the following heading: Pedido de Visto de Curta Duracao (Curta Duracao de 07 dias - SHORT STAY - 7 DAY STAY

The 7 day request must also be stipulated in the body of the email.

In addition to the Letter of invitation, the Host Company in Angola are required to provide the following updated documents - 1. Documente de arrecadacao de receitas. 2. Carta de contribuinte. 3. Dario Da Republica. 4. Alvara Comercia.

Updated South African employment letter in Portuguese explaining reason for visit, passport details and duration of stay addressed to "Ao Sector Consular Da Republica De Angola, Na Republica Da Africa Do Sul, Pretoria".

Three Months Latest Bank statements

Cape Town Angolan applicants are required to sign Visas Zone terms and conditions before submitting an application through this office

Processing time is 7-10 working days. Do not confirm flights before the visa is issued.

Kindly note that applications will be rejected if the passenger overstayed his or her welcome and received a fine from Immigration - D.E.F.A.

Costs: It is important to take note all visas are submitted to a third party Consular appointed agent and therefore the visa fee displayed on the visa are not the final costing. Additional fees apply to complement the supply chain management process, which includes: Visa center Lodgement, online payment & processing Fee. It is important to request a detailed quote before submitting an application to one of our offices. Once the invoices and visas are issued, the expenses are non-refundable.

Visas Zone charge a service fee. No representative in the Western Cape, courier fee applies.
