

## Australia Holiday Visa Requirements

The process consists of the applicant completing the online questionnaire and submitting it to us for processing! Visas Zone also provides payment on the applicant?s behalf and after completion, deliver your passport with visa to a home or office address! Submit the online form and the below documents to any of our offices for processing:

All applicants regardless of nationality, who are in South Africa at the time of making a visa application to enter Australia will be required to provide their biometrics along with their visa application. Applicants who may be partially exempt from biometric fingerprints collection include minors less than 5 years old (photo only required) and mentally or physically incapable persons (photo only required). Applicants fully exempt from providing biometrics include diplomatic representatives and their dependents, and government officials acting as a representative of a foreign government. Australia-s currently collecting biometric data from visa applicants in 33 countries across the globe. This process improves visa integrity, reduce identity fraud and improve security and safety for travelers and the Australian community. Visas Zone will STILL ASSIST travelers with a meet and greet service at the Cape Town and Pretoria Lodgement Centres.

Valid Passport (validity 6 months after date of return) - Certified Clear colour copy of Biometricdata page only.

One passport size photos (Colour).

Tourism checklist to be signed (Obtainable from our website under Australasia).

Copy of Marriage certificate and copy of South African ID.

Letter from South African Company stating: (Original) (Letter may not be signed by applicant) - (a) Dates of trip/ Duration of trip. (b) Nature of business and that the company will cover all costs (Letter may not be signed by applicant). (c) Certified Copy of Business registration if self-employed and a letter from the accountant confirming the above.

Scholars/Students - A letter stipulating the duration of stay and return dates (From School, University or College). All minors under the age of 18 must present an Unabridged Birth certificate when travelling with or without parents (Obtainable through Visas Zone). If the minor is travelling with one parent, a consent letter from the other must be presented and signed by a Commissioner of oath. A certified copy of their unabridged birth certificate and a certified consent letter from both parents are required. (1229 must be completed if - Australia, their non-accompanying parent(s) or person(s) with parental responsibility (anyone who can lawfully determine where the child/children to live) may be required to sign a consent form to give permission for the child/children to be granted an Australian visa for the purpose of travel to stay temporarily or permanently in Australia. If one parent, or person(s) with parental responsibility, has lawfully been made solely responsible for making decisions as to where the child/ children are to live, then only that parent or person needs to sign the consent form and provide the required documentation certified copies of parents sa id and marriage certificate.

Most recent 3 months bank statements.

Itinerary- flight schedule - Don-t purchase your air ticket before you have received your visa, an itinerary must be provided with provisional dates.

Accommodation: An invitation from friends OR family must be sent via post, fax OR email with a copy of their passport / valid RESIDENCE permit TO RESIDE IN Australia. Must stipulate address and contact number/s. All hotel bookings must be faxed from the hotel or travel agent-s stationary

Additional medical insurance must be provided if over the age of 75 (Obtainable from any local travel agent) Letter from your medical aid is not acceptable.

A letter from an approved panel Doctor is required if over the age of 75 and chest examinations may also be requested.

All applicants wanting to visit Australia for more than three months must provide the Australian High Commission with all the requirements above plus a chest examination from an Australian an Australian approved panel radiologists.

Important - Please take your valid passport and E-medical referral letter (Obtainable though your Visas Zone Consultant) with you to your medical examination. This is the only formal proof of identity accepted.
